

Atlwest Communications Social Media Giveaway Official Rules

Facebook

Privacy:

Information is collected in accordance with the Atlwest Communications Privacy Policy. Any personal information obtained during these Giveaways will be used for administration and for marketing purposes for the Giveaways. Personal information will not be sold or distributed to any third party.

Giveaway Dates:

The Giveaway(s) will run anywhere from one day to thirty-one days, depending on the Giveaway. (Subject to change at any time).

Eligibility:

The Giveaway(s) are open to all residents of Saskatchewan and who are 18 years of age or older as of the date of entry.
